When Paul Unks first approached me many years ago about a project to reintroduce the works of Edward Curtis, I was a bit skeptical. Our set had been given to the University of Denver back in the 1930's and is one of only a few complete sets in existence. While in recent decades, some printers have produced re-strikes from the original plates, many of those plates have been lost, destroyed or damaged, and the ones that are intact are worn from aging, exposure and repeated printing. Paul Unks of Mountain Hawk has gone a step further in craftsmanship and quality to produce his photogravures. Working from an early set of pristine images and using high-resolution photography, he has created new copper plates; then, in collaboration with a master print maker, and refining his ink and sourcing a very fine paper—a tissue that is translucent, imparting a wonderful dimensionality to the print—he has produced new photogravures of incomparable quality. Many people have remarked that the sharpness and detail are every bit as good as the best originals. As Curtis himself was able to produce just about half of his intended edition of 500, Paul's great purpose is to complete the edition—and so in a real sense to fulfill Curtis's mission.
